

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, That certain Deed of Trust (the “**Deed of Trust**”) dated October 29, 2012, from Robert Acie Goodwin, Sr. (“**Borrower**”), as Grantor to Suzie King, Trustee, filed for record in Real Property Records of Gray County, Texas as Document # 0220362, more particularly described therein, which serves as security for a Twenty-Nine Thousand, Nine Hundred Dollars (\$29,900.00) promissory note described therein (the “**Note**”) executed by Borrower, payable to Noteholder, Lori L. WHEREAS, the undersigned has been appointed Substitute Trustee in the place of the said original Trustee, upon the contingency and in the manner authorized by the Deed of Trust; and

NOW, THEREFORE, NOTICE IS HEREBY GIVEN that on Tuesday, October 1st, 2024 beginning at 10:00 o'clock am or not later than 1:00 o'clock pm, the Trustee or Substitute Trustee, will sell the following described real property, to the highest bidder for cash, subject to the unpaid balance due and owing on any lien indebtedness affecting the property which is superior to the Deed of Trust, if any, at the Courthouse of Gray County, Texas, in the area designated by the Commissioners Court of such County, or if no such area has been so designated, then at the place where non-judicial foreclosure sales of real property are customarily and regularly held in Gray County, Texas, which real property is described as follows:
